Unlimited Opportunities


- When you become an Officer in the Army, your opportunity for growth doesn't stop.

Professional Training & Development

- Cadets can participate in Cadet Professional Development Training (CPDT).
- This program provides a variety of leadership and professional development training opportunities during the summer, such as internships, attending an Army school (Airborne or Air Assault), or spending a month with an Active-Duty Army unit.
 - Cadets participating in summer training activities are considered on Active Duty for professional development and receive pay and benefits.

- Army ROTC will assist you with paying for your education, give you specialized training and years of on the job experience.

ROTC Scholarships



Army ROTC scholarships range from two, three and four-year scholarships for any academic discipline. Scholarships may be used to cover either tuition and fees or room and board. All scholarships include a monthly \$420 tax-free stipend during the school year and \$1,200 per year for books. Selection is based on academic performance and achievements, not financial need.

The Guaranteed Reserve Forces Scholarship

U.S. ARMY

Students/Cadets interested in commissioning into the National Guard or Army Reserve with a guaranteed reserve component assignment can apply for this scholarship.

For the National Guard scholarship, Cadets must be involved in the Simultaneous Membership Program (SMP) with a National Guard unit while in school and have a letter of acceptance from a local Guard unit stating that they will accept you in a SMP status. Following graduation, cadets begin a new Military Service Obligation (MSO) contract and Recruiting Operations Officer (ROO) at their university for serve eight years in the Guard, which includes training.

On Campus Scholarships

There are four-year, three-year and two-year scholarships available to students already enrolled at a university either at the graduate or undergraduate level.

Four-Year scholarships are most commonly applicable to current students who are on a five-year college plan, while Two-Year Scholarships are more common for those who attend certain participating two-year community colleges before transferring to a four-year university.

National Scholarships

Four-year Army ROTC National Scholarships are designated for high school students. The selection process is highly competitive as thousands of students across the nation apply each vear.

There are three annual scholarship boards to decide on scholarship recipients. The applications open in June of each year. **Interested students can submit applications** until March, before the last scholarship board is held.

4 year Scholarship Requirements

Be a U.S. Citizen	Age 17-31
High School Diploma or equivalent	Meet Physical Fitness Standards
Take the SAT or ACT	2.5 High School GPA

The Army awards approximately \$300 million in ROTC Scholarships each year.
